Going the extra mile:

A CCC provider ordered testing on a patient's abnormal bloodwork. The patient had anemia and was taking iron supplements. The provider discovered that he had multiple myeloma. After speaking with the patient and family about the results, the CCC provider referred him to hematology where he is getting the care he needs.

Like night and day:

A patient with severe psoriasis said it impacted every second of his life. He felt miserable. After the CCC provider referred him to our dermatologist, he returned happy. Most of his rash had cleared up! He said it was like night and day.

Evening clinics are right on time:

On Mondays and Thursdays, the CCC stays open to see patients until 8pm, increasing access for patients who can't come during the day because of work, school, and transportation barriers.

Dental health services:

Our dental clinic continues to grow! Many of our patients are receiving their first professional cleaning at the CCC! Dental services are also an important part of our diabetes care plan. In 2023, we increased our dental hygienists' hours from 7 to 26 hours a week, allowing us to see 21 patients per week. The average value per appointment is \$500. Our 2024 goal is to complete 500 dental hygiene visits at an estimated \$250,000 value of services provided to the community.

Founders Legacy Award

Dr. William "Bill" Satterwhite, Jr. (posthoumusly)

Dr. Satterwhite and his wife Phoebe had big hearts for those in the community who were less fortunate. Following his retirement in 1998, he cofounded the Community Care Center. Phoebe was very supportive and involved. His dedication, hard work, and compassion for the underserved helped the CCC become what it is today. "The heart of the clinic," Dr. Satterwhite was a legend at the CCC. One patient said, "he was funny and made you comfortable, even when you knew it was going to hurt a little bit." "He was a character, the dapper provider with a bow tie and a heart for others."

Clarice was the motivating force to get the CCC GYN clinic up and running. She cares deeply and wants to solve problems for our patients, saying "Pap smears prevent cervical cancer and save lives. It's a wonderful thing." Kind and quiet, Clarice has been serving patients at the CCC for more than 15 years. "Clarice is our rock. She meets the patients with a smile on her face, a positive attitude, and a desire to help them. And when they leave, they know they've been heard, and their needs met."

After a 42 year teaching career, Danny missed teaching and helping others. He began volunteering at the CCC after he started learning Spanish in his retirement. As a floater, Danny helps out wherever he is needed. Whether it is checking patients in, triage, or making sure kids have coloring books, he makes patients feel comfortable. Patients ask for Danny when they come to their appointments. According to Danny, what he enjoys most is the positive attitude and comradery he feels at the CCC. "When there's a challenge we say: 'How can we solve this? What can we do for this patient?' I come to give, but I receive much more."

We have expanded our mental health services with the addition of two new staff members. 




